

Privacy Policy – Gabi■Latex Online Store

1. General Information

This Privacy Policy explains how Gabi■Latex (operating at <https://gabi-latex.com>) collects, processes, and protects personal data of its Clients.

2. Data Controller

The controller of your personal data (“Controller”) is ANDRZEJ STASZEL Gabi■LTX, operating under the name Gabi■Latex.

The Controller ensures that your personal data is processed lawfully and transparently under GDPR (Regulation (EU) 2016/679).

3. Scope and Purpose of Data Processing

Personal data may be processed for:

- order processing and contract performance,
- customer service and communication,
- billing and accounting compliance,
- marketing communications (with consent),
- technical and security purposes (fraud prevention, website stability).

4. Categories of Collected Data

The Store may collect:

- name and surname,
- address, email, and phone number,
- order and payment details,
- IP address and browser information for analytical purposes.

5. Legal Basis for Processing

Data is processed under:

- Article 6(1)(b) GDPR – contract performance,
- Article 6(1)(c) GDPR – legal obligation (accounting),
- Article 6(1)(a) GDPR – consent for marketing,
- Article 6(1)(f) GDPR – legitimate interests (security, anti-fraud).

6. Data Retention Period

Data is stored as long as necessary for order fulfillment, legal compliance, or marketing consent validity. After this period, data is securely deleted or anonymized.

7. Data Sharing

The Store shares data only with entities necessary for order fulfillment and technical maintenance: payment providers, couriers, hosting, accounting, and legal services. Data is not transferred outside the EEA without adequate protection.

8. Data Subject Rights

You have the right to:

- access, correct, or delete your data,
- restrict or object to processing,
- withdraw consent at any time,
- file a complaint with the Polish Data Protection Authority (UODO).

9. Cookies Policy

Cookies are used to ensure website functionality and analyze traffic. They store preferences, shopping cart data, and may be used by analytics tools like Google Analytics. You can disable cookies in your browser settings.

10. Security Measures

The Store uses SSL encryption, restricted access, and secure hosting to protect personal data. All partners comply with GDPR security standards.
